FOOD STOCK TO CUSHION INFLATION IMPACT: RBI BULLETIN

Limited impact seen on food inflation from kharif delays

New Delhi, July 22

WHILE THE UNEVEN progress of the southwest monsoon has delayed kharif sowing, its impact on food inflation is likely to be limited, the Reserve Bank of India's staff said in its July Bulletin.

High public foodgrain stocks should provide some cushion against price pressures, the central bank staff said.

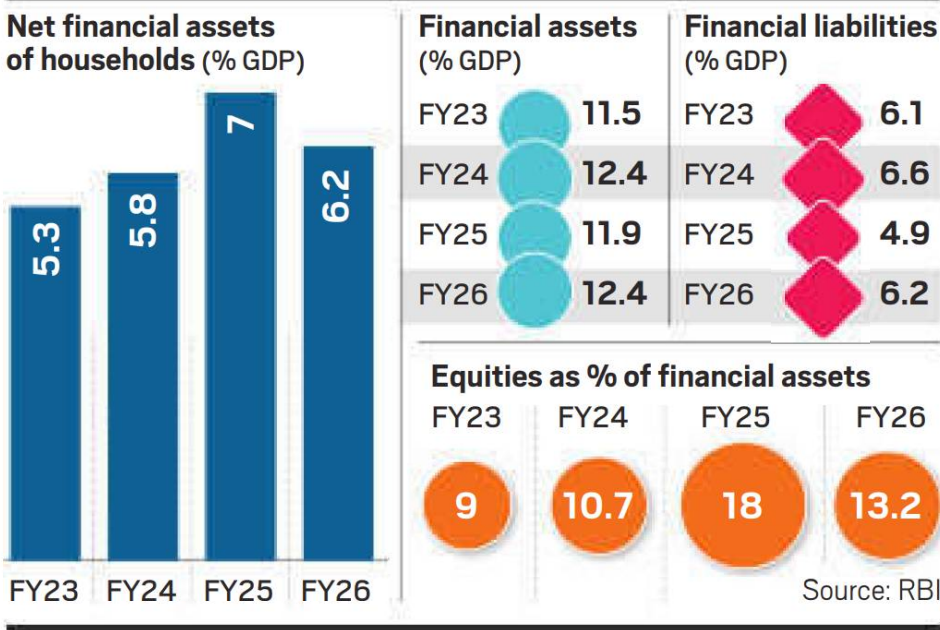
"The farm sector is witnessing an uneven southwest monsoon, but the impact on food inflation may be mitigated by comfortable foodgrain stocks," they said in an article on the state of the economy.

According to data from the India Meteorological Department (IMD), India received 276.8 mm of rainfall between June 1 and July 21, which is 21% lower than normal.

The IMD has projected rainfall during the monsoon season to be 90% of the long-period average, raising concerns over food inflation.

Food prices are already on

the rise. Retail food inflation rose to 5.32% in June from 4.78% in the previous month. This pushed headline CPI inflation to an 18-month high of 4.38% in June, breaching the RBI's medium-term target of 4% for the first time since January 2025.

Robust economy

The Indian economy remained buoyant in June, supported by improving rural demand and firm urban

demand, the RBI staff said.

"The global economy is dealing with uncertain economic environment, supply chain disruptions, and fragmented trading relationships. Amidst these uncertainties, India remains among the fastest growing major economies across the globe and has been able to sustain the momentum in economic activities through June," they said in the State of the Economy article in the Bulletin.

Net financial assets of households fall in FY26

NET FINANCIAL ASSETS of households moderated to ₹21.4 lakh crore or 6.2% of GDP in FY26, compared with ₹22.3 lakh crore or 7% of GDP in the previous year as financial liabilities grew sharply, data from RBI's July Bulletin show.

Financial liabilities rose to ₹21.4 lakh crore or 6.2% of GDP in FY26 as compared with ₹15.7 lakh crore or 4.9% of GDP in FY25.

The share of equities dropped to 13.2% after rising each year from FY20 onwards.

Indian exporters may get \$7-bn US tariff refunds

INDIAN EXPORTERS WHOSE goods were subject to reciprocal and penal tariffs in the US market for about ten months since April, 2025 may recoup as much as \$7-8 billion.

The US Customs and Border Protection (CBP) has started settling the claims regarding these levies which the US Supreme Court invalidated, a senior industry official said.

The total incidence of these extra tariffs over MFN rates on Indian goods is estimated to be around \$12 billion, but over a third of that amount may not be recoverable.

Importers of Indian goods or intermediaries actually paid these levies. Recovery will be easier in cases where Indian exporters have related-party outfits in the US.

The refunds will be issued only to importers on record and authorised customs brokers with a US bank account. Any gain from the refund process for Indian exporters would depend on how they structured their transactions when the US increased additional tariffs on India between April and August last year. The tariff started from 10% in April to 50% by August, said Ajay Sahai, CEO and Director General of the Federation of Indian Export Organisations (FIEO).

Some listed companies importing into the US through their local subsidiaries have already announced the scale of refunds received in regulatory filings. Elgi Equipments, for instance, has announced that it has received ₹25.6 crore, ADF Foods got back ₹19.97 crore and Jash Engineering received ₹4.5 crore. The US has accepted Camlin Fine Sciences' refund claim of ₹9 crore. There have been other cases where claims have been accepted or refunds released, but these have not been disclosed as the exporting companies are not listed, said Pankaj Chadha, chairman of the Engineering Export Promotion Council (EEPC). Other major Indian companies with subsidiaries in the US, like Pearl Global and Aditya Birla Group entities, could also be eligible for refunds.

About 53% of India's exports to the US—mainly textiles and apparel—faced these high tariffs, making them the biggest contributors to refunds. Of the estimated \$12 billion in taxes imposed on India, textiles and apparel may account for about \$4 billion, engineering goods another \$4 billion, and chemicals about \$2 billion, said Ajay Srivastava, founder of Global Trade Research Initiative (GTRI).

Less than a third of rural households report rise in income, says Nabard

ONLY 27.7% OF rural households reported an increase in their income compared to the previous year, according to the latest survey by the National Bank for Agriculture and Rural Development (Nabard).

This is the lowest proportion of the population stating that their income has increased since Nabard launched the bi-monthly survey titled 'Rural Economic Conditions

and Sentiments' in September 2024.

Over 52% of responded households stated that their incomes remained unchanged while 19.8% reported a decline in income.

"Reflecting moderation in consumption, the proportion of respondents reporting an elevation in consumption expenditure declined to 74.1%, marking only the second instance since the commencement of the survey that this proportion has fallen below 75%," the 12th round of the survey stated.
